HIGHLANDS AND ISLANDS ENTERPRISE

PUBLIC SERVICES REFORM (SCOTLAND) ACT 2010: STATEMENT FOR 2019/20

Under the Public Services Reform (Scotland) Act 2010, we have, along with other public bodies in Scotland, a duty to publish annual public statements relating to our expenditure in the following areas:

- Public relations
- Overseas travel

In addition, the Act requires public bodies to publish details on:

Efficiency, Effectiveness and Economy

HIE is constantly engaged in identifying opportunities to increase efficiency, lower costs and improve service quality. In ensuring Block B (HIE's management and administration budget) remains on target, costs must be contained, and inflation absorbed.

HIE actively looks to make the best use of space available in its offices and is working on a number of accommodation agreements with public sector organisations. In addition, as lease expiry dates approach, we are complying with Scottish Government policy on floor space and energy efficiency as we consider whether to extend the lease or seek new premises that deliver best value.

The move to Western Isles Council Public Sector Building in Stornoway has resulted in substantial savings on our premises costs and improve our carbon impact with a reduction in our occupied floor space.

We have also continued to reduce our off-site storage costs for paper files resulting in savings of 40% over the past 2 years.

HIE has reviewed its provision of facilities management in our Inverness office. During 2019/20 the delivery plan was implemented, and contracts mobilised that have resulted in significant savings for HIE and other organisations that occupy the same building.

Staff travel is a significant cost for HIE, especially given the geography of our region. However, this is mitigated by having a central travel team which makes all bookings, having a policy of only booking standard class and seeking to rationalise travel. To this end we are making use of Skype for Business rather than staff travelling for internal meetings. We have held two 'All Staff Strategy' events using Skype, where different presentations were led by directors in locations throughout the region.

HIE have committed to stringent vacancy and recruitment management and continue to generate recyclable savings through lower staff replacement costs and the regrading of posts. These savings not only contribute to the costs of HIE's pay award but also help to free up capacity to bring in different skill sets and capability to deliver HIE's strategic plan.

HIE is actively putting contracts in place to ensure best value, clear service level agreements (SLAs) and improved quality. Where possible central frameworks are utilised to save duplication of effort and achieve best value.

The impacts of COVID-19 on future working practices, including office use and travel, continue to be monitored and will be reviewed as the pandemic progresses.
