## PUBLIC SERVICES REFORM (SCOTLAND) ACT 2010: STATEMENT FOR 2023/24

Under the Public Services Reform (Scotland) Act 2010, we have, along with other public bodies in Scotland, a duty to publish annual public statements relating to our expenditure in the following areas:

Our statement covering the financial year 2023/24 is set out below and includes costs relating to Wave Energy Scotland, which was established as a subsidiary of Highlands and Islands Enterprise in December 2014, Cairngorm Mountain (Scotland) Limited, which was established as a subsidiary of Highlands and Islands Enterprise in December 2018 and Orkney Research and Innovation Campus, which is a joint venture with Orkney Islands Council.

## **Sustainable Growth**

HIE's new Strategy 2023-2028 launched in August 2023. It sets out a new vision, purpose, strategic objectives, actions and key outcomes we seek to deliver across the region and places the just transition to net zero as a core cross-cutting theme. Our new vision for the region also emphasises the importance of sustainable growth: "The Highlands and Islands is a leading net zero region with a dynamic wellbeing economy, which benefits its growing population and makes a valued contribution to Scotland."

Our purpose is to build and sustain a greener, fairer and more resilient region that benefits everyone with key outcomes of:

- A more balanced population and growing skilled workforce.
- An increase in average wages
- An increase in economic and community benefit from the transition to net zero
- An increase in productivity and innovation

We are delivering through focusing on our four pillars: People, Place, Planet, Prosperity with cross-cutting themes of net zero, fair and inclusive growth, and regional transformational opportunities running through our framework. These represent key strategic drivers in terms of what is delivered and how.

Once-in-a-generation opportunities extend across the region and we are at the forefront of sectors vital to transforming Scotland's economy such as energy, life sciences and space. More traditional sectors such as tourism, food and drink and creative industries have significant potential to innovate, evolve and grow ensuring their long-term contribution to the regional economy. Capitalising on these opportunities will be vital to our ambition to deliver for each and every part of our region.

We will tackle poverty, inequalities and inclusive growth through growing a wellbeing economy and accelerating community wealth building. Community wealth building can drive new business models and create new opportunities for increasing community benefit. Retaining and attracting young people to the region through investing in these opportunities, supporting young entrepreneurs, graduate placements and working with partners to deliver population initiatives is key.

We recognise that businesses and communities continue to be impacted by economic uncertainty, the cost of doing business, legislation and regulation, and access to skilled labour. Transitioning to net zero, fair work and innovation will be key to building resilience and sustainability.

Infrastructure such as housing, transport, education and digital alongside planning and delivering skills and training will be critical areas of partnership working to achieve the ambitions and address the challenges and opportunities set out in our strategy. These can only be accomplished through collaborative working, involving partnership with government and across the private, public and third sectors.

## **Efficiency, Effectiveness and Economy**

HIE is constantly engaged in identifying opportunities to increase efficiency, lower costs and improve service quality. In ensuring HIE's management and administration budget remains on target, costs must be contained, and inflation absorbed.

Aligned to the HIE Strategy 2023-28, HIE has developed a Best Value Plan designed as a framework to measure effectiveness and efficiency and drive improvements. The plan is built around a set of key performance indicators to enable us to measure progress and drive improvements across a number of themes such as customer experience, financial spend, service quality, data use, and project management. To support this activity a group is in place to actively pursue and track efficiency savings.

HIE continues to actively look to make the best use of space available in its offices, and to utilise lease breaks to rationalise our footprint and reduce accommodation costs.

During the 23/24 period HIE continued to monitor the use of desk and meeting spaces in our offices and identified opportunities for further co-locations which came to fruition during 2024. These included welcoming Skills Development Scotland into An Lòchran, Inverness and Solarhus, Lerwick. These co-locations have allowed HIE to recover occupation costs (£24k in An Lòchran and c.£15k in Lerwick) whilst allowing SDS to vacate underutilised buildings in both locations.

Scottish Land Commission continue to co-locate in An Lòchran, using 8 desks giving HIE further contribution (£24k) towards the running costs.

Additionally, during 2024 we identified alternative accommodations with UHI North West & Hebrides in Thurso and Auchtertyre. These will delivery significant savings from early 2025. (approx. £65K in Thurso and £10K in Auchtertyre)

The public sector office accommodation requirements have been in a state of significant flux over the last couple of years and continue to be so. HIE FM continue to be in conversation with all appropriate partner agencies, local authorities and the UHI network to ensure opportunities for co-location and estate rationalisation are grasped when they present themselves.

HIE have committed to stringent vacancy and recruitment management and continue to generate recyclable savings where appropriate, encouraging a different approach to resourcing, challenging like for like replacements, looking at different delivery models to drive efficiencies. These savings contribute to the costs of HIE's pay awards and additionally free up capacity to bring in diverse skill sets and capabilities necessary to deliver on HIE's strategic plan. There is an increased focus on resource for front line delivery and the use of internal expertise/specialist.

HIE has a procurement strategy in place which supports efficiencies and Best Value, ensuring that all procurement activities are conducted in a manner that maximises value for money and improves service quality.

HIE's comprehensive approach to improving efficiency, effectiveness, and economy is evident through its commitment to continuous improvement and the implementation of strategic frameworks to support this. These efforts ensure that HIE is regarded as an organisation that is effective and efficient, inspires innovation, and achieves successful outcomes, both internally and externally.
